

Evidence of your finances for Student visa applications

London

As part of your visa application, the UKVI will assess whether you have sufficient funds to study in the UK. Your visa application must demonstrate that you have sufficient tuition and maintenance funds for your course of study, less any fees paid.

In London

Course fees + £1,483 per month of studies (up to 9 months)

Outside of London

Course fees + £1,136 per month of studies (up to 9 months)

Your bank statement must be an original and not a scan, online printout or photocopy. It must feature an official bank logo and company or branch address.

Account name

You can use money held in an account belonging to you or your parent (or legal guardian). If using the account held by your parent(s)/legal guardian(s) you must provide evidence (for example a birth certificate) to prove you are related. You are required to provide a financial consent letter, stating that their funds are available to use for your studies in the UK.

Date of statement

The bank statement must not be dated more than 31 days before the visa application on date (which is associated with the payment of the visa application on fee).

The required level of funds must be held in the account for a minimum of 28 consecutive days (finishing on the date of the closing balance).

You have applied for the MSc Business Management programme and will be staying in independent accommodation.

Course Fees

£16,000

Maintenance Funds

£13,347

Fees Paid

£4,350

You are required to show

(£16,000 + £13,347) - £4,350 = £24,997

Example 2

You have applied for MSc programme and will be staying in independent accommodation.

Course Fees

£14,500

Maintenance Funds

£13,347

Fees Paid

£14,500

You are required to show

(£14,500 + £13,347) - £14,500 = £13,347
